**Scheme at a glance for Research Assistance in Technological Aspects in Disability Studies**

The objective of this scheme is to provide financial assistance to carryout research in the area of Technological aspects in disability studies and develop implements to aid physically challenged. Any faculty member with an innovative idea working in government, government aided or government controlled self supporting Engineering college/Medical College/Polytechnic /other colleges in Kerala can apply for financial assistance under this scheme. Also, any qualified person with disability (with 40% &above disability) can apply through government Engineering college/Medical College/Polytechnic in Kerala for financial assistance. The research project shall be carried out in an Engineering college/Medical College/Polytechnic college (government, government aided or government controlled self supporting institutions) in Kerala. One of the faculty members who is currently working in the institution shall be co- investigator/guide. The maximum eligible funding for a project will be **Rs. 4,00,000/-**. Depending on the merit of the project this amount will be decided by the Research Advisory committee (RAC). The application for financial assistance in the prescribed format should be submitted in triplicate to the Director, Centre of excellence for Disability Studies (CeDS), Thiruvananthapuram. The investigators shall make a presentation of the project before the Research Advisorycommittee.

Subject to the availability of funds, proposals for financial assistance will be screened and approved by the Research Advisory Committee, which will subsequently be sanctioned by the Director, CeDS. Funds will be released in installments through the head of the institution where the project is being carried out. The progress report and utilization of funds shall be reported in every six months. The final report, statement of expenditure, utilization certificate, equipment(s) purchased (if any) and the products developed (if any) shall be submitted to CeDS after successful completion of the project.

### **Scheme for Research Assistance in Technological Aspects in Disability Studies**

#### **Introduction**

The objective of this scheme is to provide financial assistance to carryout research in the area of Technological Aspects in disability studies and develop implements to aid physically challenged.

#### **Eligibility (who can Apply)**

Any faculty member with an innovative idea working in government, government aided or government controlled self supporting Engineering college/Medical College/Polytechnic /other colleges in Kerala can apply for financial assistance under this scheme. Also, any qualified person with disability (with 40% & above disability) can apply through the faculty of any government Engineering college/Govt. Medical College/Govt. Polytechnic in Kerala for financial assistance under this scheme. The research project shall be carried out in an Engineering college/Medical College/ Polytechnic college (government, government aided or government controlled self supporting institutions). One of the faculty members who is currently working in the institution shall be co-investigator/guide.

#### **Guidelines**

1. The application for financial assistance in the prescribed format should be submitted in triplicate to the Director, Centre of Excellence for Disability Studies (CeDS),LBSITW Campus, Poojappura, Thiruvananthapuram-695012. The person with disability who is not a faculty member should submit the 'Certificate of Disability' from the District Medical board certifying the degree of percentage of disability issued **not earlier than 12 months** prior to the last date of submission of application along with the application form.
2. The investigators are requested to submit a detailed proposal in the "Prescribed Format" in the address mentioned above at least 90 days prior to the start date of the project, so as to enable, CeDS to sanction proposals scrutinized and recommended for funding by the expert committee.
3. Item wise financial estimates should be mentioned clearly in the proposal submitted, showing rates, quantity and total for each item. The maximum allowable expenditure for consumables, travel and other expenses for a project shall not exceed 20%, 10% and 10% of the total estimate respectively.

#### **Rules**

1. These rules are called the 'Rules for grant of Research Assistance' in technological aspects in Disability Studies.

2. Under these rules financial assistance will be granted to the investigators (any **person with disability**\* (minimum a graduate in Science /Diploma holder in Engineering) with an innovative idea and/or a faculty who is working in an Engineering College/Medical College /polytechnic college/ other colleges in Kerala) for conducting research projects related to technological aspects in Disability Studies. (\*As per the PWD ACT, 'Person with Disability' means a person suffering from not less than 40% of any disability as certified by a medical authority. *Generally, candidates who have a minimum of 40% disability alone will be eligible to apply for this quota. Hence candidates seeking financial assistance will have to satisfy the eligibility criteria prescribed by the concerned regulatory bodies for 'Persons with Disabilities'. No certificate other than the mentioned above will be considered for determining disability*). .

**\*Persons with different types of disabilities like**

1. **Blindness**
  2. **Low vision**
  3. **Leprosy-cured**
  4. **Hearing impairment**
  5. **Loco-motor disability**
  6. **Mental illness**
3. Financial assistance may be limited to specific items of expenditure or to cover a part of the expenditure on the whole function.
  4. Funding Norms
    - a The maximum eligible funding for a project is limited to Rs.4,00,000/-.
    - b Subject to availability of funds, proposals for financial assistance will be screened and approved by the RAC, which will subsequently be sanctioned by the Director, CeDS.
    - c The investigators shall make a presentation of the outcome of the research before the RAC constituted for the purpose.
    - d Financial assistance will be released to the investigator through the Principal of the concerned institution) in three installments. (40% of the sanctioned amount – at the start of the project, 30%- after the first review, 30%-after second review).
    - e The progress report and utilization of funds shall be reported every six months.
    - f The final report, statement of expenditure and utilization certificate shall be submitted after successful completion of the project.
    - g The whole or part of the granted money remaining unutilized within the prescribed time limit should be refunded to CeDS by remitting back the balance amount.
    - h Utilization certificate and Statement of expenditure (two copies) shall be furnished to **The Director, CeDS** within three months from the last day of the programme. The accounts should be audited by the accounts officer of the institution/Chartered Accountant.

- i The CeDS reserves the right to order verification/audit of accounts by any officer authorized by it and is open to audit by Accountant General. The accounts shall be kept safely for a **minimum period of three years**.
  - j The recipient and the institution shall comply, with such other conditions as may be suggested in the 'guidelines' issued in this regard from time to time.
  - k If commercial benefits are derived from the knowledge generated from the projects, 50% of such gains shall be shared with CeDS subject to a maximum of the amount sanctioned by CeDS.
5. If the Investigator who is involved in the project leaves the institution (transfer, retirement, change of job etc.), the project may be transferred to another investigator to complete the project.
  6. The sanction of research assistance under this scheme does not automatically entail any right to the investigators for further claims of funding from CeDS.
  7. The equipment(s) purchased for the project and products developed will be the property of CeDS and on completion of the project shall be transferred to CeDS.

**Terms and Conditions**

1. The scheme is constituted for the purpose of providing assistance in the form of grants to carryout research work in developing implements for use by physically challenged.
2. Grant will be released to the Principal Investigator/Co-investigator/Guide of the project through the Head of the institution.
3. The maximum duration of the project will be two years from the date of start of the project.
4. The date of start of the project should be intimated by the Institution authorities/Principal Investigator to CeDS. It will, in no case be later than one month after the receipt of the information letter.
5. On completion of the project, 3 copies of the final project report on the work done should be sent to the CeDS along with the utilization certificate (UC) and statement of expenditure (SE). The Utilization Certificate and Statement of Expenditure should be countersigned by the Principal of the Institution
6. The institute will maintain separate audited accounts for the project.
7. The institute will not entrust the implementation of the work for which the grant is being sanctioned to another institution nor will it divert the grant receipts to other institute as assistance.
8. The CeDS reserves the right to terminate the project at any stage if it is convinced that the grant has not been properly utilized or appropriate progress is not being made. In addition, the CeDS may designate Scientist/Specialist or an Expert Panel to review the work done.
9. If the PI to whom the project has been sanctioned wishes to leave the Institution where the project is based, the Institute/PI will inform the same to the CeDS and in

consultation with CeDS, evolve steps to ensure successful completion of the project, before relieving the PI.

10. Investigators must acknowledge the CeDS in reports and technical/scientific papers published based on the research work done under the project.
11. If the results of research are to be legally protected by way of patent/copy rights etc. the results should not be published without action being taken to secure legal protection for the research results.
12. The knowledge generated from the project will be the property of CeDS and should be properly acknowledged. Transfer to technology generated shall be done in consultation with the CeDS.
13. If commercial benefits are derived from the knowledge generated from the projects, 50% of such gains shall be shared with CeDS subject to a maximum of the amount sanctioned by CeDS.
14. The CeDS may enforce additional guidelines for the operation of the project from time to time and the Institution/Investigators are required to observe such directions in the conduct of the research work.
15. The equipment(s) purchased for the project and products developed will be the property of CeDS and on completion of the project shall be transferred to CeDS.
